All witnesses testifying will be "sworn" prior to their testimony. However, the public is permitted to comment without being sworn. Unsworn testimony will be given appropriate weight and credibility by the City Commission.

- Commented that there has been a vacancy on the board and stated he would like to see the vacancy filled. He commented that Christina Vogl has an application in with the City and thinks that her application should be reviewed and considered.

2. PRESENTATION OF THE APPLICATIONS FOR THE BUSINESS IMPROVEMENT REIMBURSEMENT PROGRAM FOR FY 2025 (RC):

RESOLUTION No. 03-2025 CRA; A RESOLUTION OF THE BOARD OF COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF STUART, FLORIDA, AUTHORIZING AWARD TO APPLICANTS FROM THE BUSINESS IMPROVEMENT GRANT PROGRAM FOR FISCAL YEAR 2025

Jordan Pinkston, CRA Program manager, presented the program description, program background, past improvements, program accomplishments, program goals, public outreach, FY 2025 applications - Claunch Animal Hospital, Downtown Stuart Retail, LLC, Maria's Cafe, Idella, LLC, staff recommends approval of \$36,350.00 to reimburse the applicants.

Board Member Manera asked if there is follow-through to ensure the improvements were made before applicants get the money, asked if the animal hospital is highly visible in order to benefit the city residents, and commented that Maria's improvement is just beneficial to the business and not the residents.

Ms. Pinkston responded to Board Member Manera.

Vice Chair Moser asked if the animal hospital had an arborist come see the roots of the trees to ensure it was not ruining the parking lot, and asked if the awnings would be going out onto the sidewalk at Idella LLC.

Representatives from each entity responded.

3. DISCUSSION AND DELIBERATION - SCOPE OF WORK FOR COMMUNITY VISIONING AND MASTER PLAN FOR THE CRA

Pinal Gandhi Savdas, CRA Executive Director, presented the items for the scope of work for CRA visioning and master plan, existing and proposed districts,

Chair Brechbill stated he would like the CRB to determine what type of business we are looking to have for economic growth, and he asked Board Member James if the items Ms. Gandhi-Savdas has presented will fulfill the sheet he provided last month.

Board Member James stated he believes it will but asked, to what extent they should look into this, as he felt the Commissioners were not on board to hire a consultant and move forward.

Board Members continued a brief discussion on moving forward with the consultants, workshops, and master plan.

Ms. Gandhi-Savdas stated this is just a broad vision, for an expansion of the downtown and the future of it.

Vice Chair Moser stated she would like to see and review publicly-owned property because we have more control over that. Stated she would like to see a charette style workshop and have specialist who know how to engage the public. She would like to see the major streets that go to schools be an important review, make the city a four-season city.

The Board discussed how they would like the workshops to occur, night time and weekends.

PUBLIC COMMENT:

1. Keith Gilbert - Stuart; Stated he would like to represent some of his neighbors who will not be able to attend these workshops.

Board Member James stated he wanted to commend the board and the commissioners for having this conversation, listening, and moving the City forward.

Ms. Gandhi Savdas stated she would bring back to the CRA the amended CIP list.

Chair Brechbill would like to see the parcels that the City owns in the CRA that we have no use for and can possibly sell to private entities.

STAFF UPDATE

Ms. Gandhi-Savdas stated that Vice Chair Moser had asked for an update on what homes have been built by habitat by humanity. Ms. Gandhi-Savdas stated that 25 homes were built by habitat and presented other homes that were rehabbed by "Brush with Kindness" program. She continued providing statistics.

PRESENTATION - COMMUNITY REDEVELOPMENT AGENCY (CRA) ACQUIRED PROPERTIES

Summary Explanation/Background Information on Agenda Request:

As directed by the Community Redevelopment Board, staff prepared a list of properties that have been acquired by the Community Redevelopment Agency. Please note that properties acquired by the Community Redevelopment Agency are generally considered to be city-owned.

The CRA acquires properties to address blight and promote community revitalization. The CRB and CRA Boards then direct the use of these properties, often through the Redevelopment Plan, to achieve specific goals. This might involve selling, leasing, or retaining properties for public use. The CRA must ensure that the disposal or retention of properties is in the public interest and aligns with the Community Redevelopment Plan.

Below is a list of properties acquired by the CRA (see attached map):

- 55 NW Dixie Hwy (Referred to as North Point - Vacant parcel)
- 310 SW 1st Street (Azul Multi-family Development- currently leased)
- 325 SE Ocean Blvd (Vacant parcel)
- 330 SE Osceola St (Vacant parcel)
- 710 SE Martin Luther King Jr. Blvd (Future Project Lift site)
