RESOLUTION No. 96-2025; A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, OF MARTIN COUNTY, FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR THE CITY OF STUART IN MARTIN COUNTY FOR FISCAL YEAR 2026; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Michael Mortell, City Manager, reported on the purpose of this meeting as required by Florida Law and announced the final millage rates of the City rollback rate for fiscal year 2026, 4.7014 mills. The City is proposing a millage rate for the fiscal year 2026, which exceeds the rollback rate by 4.22 percent, of 4.9000 mills. He further stated that the increase is to fund current operations and accommodate normal increases in the cost of those operations.
