1. PRESENTATION OF THE MARTIN LUTHER KING JR. BLVD STREETSCAPE IMPROVEMENTS PLAN

Pinal Gandhi-Savdas, Community Redevelopment Agency (CRA) Executive Director, provided a brief history of the project and introduced Brian Good of Kimley Horn Engineering. Mr. Good presented the existing street scape, survey results, proposed street scape, proposed landscaping right-of-way, the community input, and overall project benefits. Timeframe expectations are scheduled for construction in 2028.

Board discussion included the impound section for parking location (behind the Public Safety Building), travel lane width, clay paver durability, the right-of-way from the School Board not yet granted, sidewalks, and bulb-out concerns. Further discussions about shade trees, impacts of expanded sidewalks, tree hardiness, on-street parking the ingress/egress for the Girls and Boys Club, and the option of a traffic signal.

Commissioner Giobbi suggested Board Member Bonnie Moser be the contact person because she communicates with multiple people about her shade tree recommendations and we should have one contact person for her suggestions of the information to be clearly represented. It was agreed that the City Manager would be the contact.

Additional topics to consider were future bus stops, bike racks, flashing light signals, and LED blinker stop signs.
